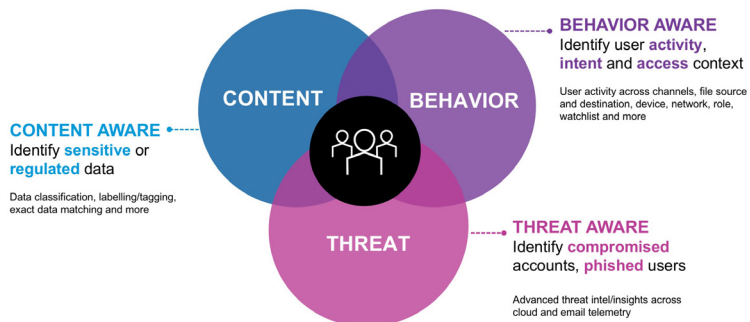


Figure 1: Understanding and mitigating user risk.

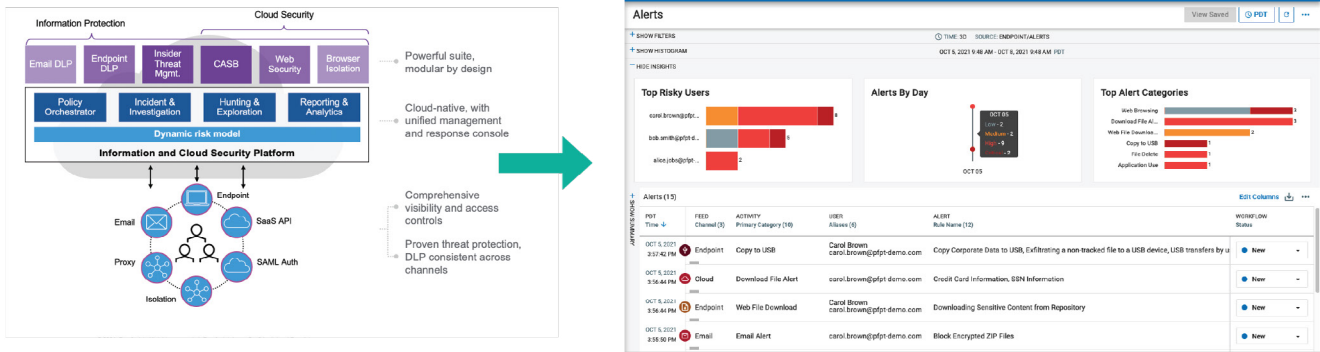


Figure 2: Proofpoint Information Protection—People-centric. Cross-channel. Purpose-built platform.

Proofpoint Enterprise DLP includes common DLP classifiers. It has more than 240 customizable sensitive data detectors and document tagging. You can apply our built-in detectors across channels. Or you can build custom ones using advanced content matching techniques like data matching and indexed document matching. You can also add optical character recognition (OCR) to your detectors. This lets you detect sensitive data in images. You can combine detectors into sets by user group, use case, channel and region. For our existing single-channel DLP users, our DLP classifiers and detectors automatically extend to a new channel, such as a cloud app, web or endpoint. You can also augment Enterprise DLP through integration with Proofpoint Intelligent Classification and Protection. This is our AI-powered data discovery, classification and automated labeling solution.

Proofpoint Enterprise DLP includes a unified alert and investigations interface. This helps you respond quickly to alerts. And because visibility anchors on the person, you can shut down any cloud account when you find that it is compromised. Or you can apply encryption to suspect email.
